January 13, 1976

The meeting of the Charter Commission, Msgr. Charles A. Kekumano, Chairman presiding, convened at 3:30 PM at the Cameron Center, Conference Room Jan 13, 1976

Chairman Kekumano in calling the meeting to order stated that the Commission should be able to complete the second draft of the Charter today. Also, that he would release the "public publicity" to the press at the end of the week; so that the public would know "where we are at now" and "what we are probably coming up with". He said that during the week of January 26, we would go the public with the "public sessions" as a "second round" with a "good document", and "if there are any controversies or disagreements from the public we will discuss them at our next meeting on February 3rd". All commissioners agreed.

Chairman Kekumano stated that all Commissioners need not be at all the sessions at the same time; that they could choose whichever sessions they wanted and requested that he be informed as to their desires. All agreed. Mr. Chairman instructed commission secretary to distribute copies of the third draft of the charter to all public libraries and places of public sessions.

Discussion:

Comm. Sodetani suggested that this Commission ask the Council if they (Council) has any proposals to add to this Charter. Chairman Kekumano said the Council has had ample time for further in-put since the first meetings. More discussions - that they Council, according to law may submit anything to the County Clerk after the submittal of a document by this Commission. *

More discussion followed on the matter of ethics - some felt "employees" should not include those menial tasks - janitors, etc. It was the consensus that "employees" included ALL employees of any department and/or agency of the of the government.

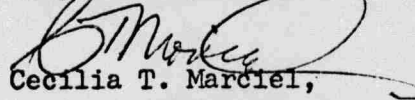
