DESCRIPTION OF BUDGET ITEMS

1. Salary - A monthly payment for the administrative coordinator.
2. Fringe - A monthly payment complying with legal standards of granting the following benefits to hired personnel: Social Security, Unemployment Compensation, Temporary Disability and Workmen's Compensation.
3. Travel - Mileage costs encompassing traveling long distances for meetings on the island of Maui and in the performance of duties as requested by the Commission.
4. Office Rental - Rental of office space in the Maui Medical Group Building Annex.
5. Office Equipment Rental - Rental of chairs, desks and equipment.
6. Office Supplies - Paper, pencils, pens, tape, stationery, tape cassettes, steno and legal tablets and whatever else is needed to efficiently run the office.
7. Other -
 - a. Xerox - An allocation to permit the xeroxing of materials needed by the Commissioners and/or distribution to the public.
 - b. Telephone - A monthly payment of approximately \$15.00 for a business phone and an estimated \$15.00 a month for long distance calls.
