Bob Jones, Maui News:

Said that their first priority would be the lay-out and publication of the tabloid - legal supplemental of the Charter for distribution to the public on Sept 8, 1976, as previously arranged by and with the Commission and the Maui News. Also, that the flip charts for the Speakers Bureau would be completed after that; a total of 15 charts would be made. Pete Rabasa would do art work and work with Miss V. Marugg, cartoonist (hired by Commission). When asked by Chairman if the work (flip charts) would be done in color, Jones replied that color would increase cost by \$60.00. Further discussion followed- Jones also said that if Commission increased charts by three more pages, additional cost would be \$300. and made of index card material.

Honokawai Taxpayers Ass'n

George Apo and Mrs. Stegmullwr said their organization would make presentation of \$1500. to the Mayor to be used "for an educational program for the public by the Commission". Chairman Edwina Bright agreed and thanked them for their generosity.

R. Jamieson Associates:

Mr. Jamieson, in outlying his work, told the subcommittee that he planned to use some cartoons his firm would create, altho' not quite sure; he would design some ads and plan some "attention getters".

Victoria Marugg:

Made presentation in detail of cartoons to be used in the flip charts and posters; said she would work with Pete Rabasa, artist Maui News, that she would/material to him by September 2. She requested payment be made to her by Sept 2 as she is leaving for the mainland.
