Chairman and Members:

Your Committee of the Whole, having met on August 3, 1988, makes reference to Resolution No. 88-70, As Amended, entitled "PROPOSING AN AMENDMENT TO THE REVISED CHARTER OF THE COUNTY OF MAUI (1983) RELATING TO ESTABLISHING PLANNING COMMISSIONS FOR MAUI AND MOLOKAI". The purpose of the resolution is to propose a Charter amendment which would create a separate County planning commission for the island of Molokai.

Your Committee notes that on July 15, 1988, the Council passed Resolution No. 88-70, As Amended, on first reading.

At its August 3, 1988, meeting, your Committee received testimony from the general public in support of the resolution. The testimony indicated that the proposed amendment would enhance local participation in government decision making, and would eliminate the costs associated with the current Planning Commission's travel to Molokai.

Your Committee notes that pursuant to Section 14-1.1 of the Revised Charter of the County of Maui, the Council may initiate Charter amendments by resolution adopted after two readings on separate days and passed by a vote of six or more members of the Council.

Your Committee of the Whole RECOMMENDS that Resolution No. 88-70, As Amended, entitled "PROPOSING AN AMENDMENT TO THE REVISED CHARTER OF THE COUNTY OF MAUI (1983) RELATING TO ESTABLISHING PLANNING COMMISSIONS FOR MAUI AND MOLOKAI", PASS SECOND AND FINAL READING.

Adoption of this report is respectfully requested.
