In order to meet the requirements of Article 14 of the Maui County Charter and the State Attorney General, the proposed resolution must be adopted by the Council after two readings on separate days and the Charter amendment language must be received by the State Attorney General at least 60 days prior to Election Day. In order to meet those requirements without scheduling a special Council meeting, the proposed resolution must pass first and second readings at the Council meetings scheduled for August 21, 1996 and September 4, 1996, respectively.


